Topic Descriptions

Valve & Hydrant Installation & Maintenance: This course is designed to familiarize the individuals in attendance with the proper installation and maintenance of various distribution system valves and proper hydrant wet and dry barrel installation and maintenance.

Excelling in Worksheets & Logs: This course is designed to familiarize the individuals in attendance with an understanding of how to set up and update spreadsheets, for uses such as meter logs, well logs, and pumping data.

Meter & Meter Testing Procedures: This course is designed to familiarize the individuals in attendance with the different types of meters, proper installation of meters and meter testing procedures.

Tuition Costs Per Class Per Year

This CEU Training Program for Water System Operators will be subsidized by the DOH, Safe Drinking Water Branch for 3 years and is designed to be self-sustaining on tuition fees after the 3 year period. This means that tuition fees will increase each year.
